Why is environmental protection important in Angola?

Policy, legal and administrative framework The necessity for environmental protection and the requirements for achieving sustainable development are founded on the right of all citizens to live in an unpolluted, healthy environment, as well as the duty to defend and preserve it, as defined in Article 39/1 of the Constitution of Angola.

Why should Angola restructure its Environmental Fund?

3.5.1. Recommendations, policies and standards developed to facilitate the restructuring of Angola's environmental fund to serve as a long-term source of finance for environment and conservation area management with diversified funding sources and access to additional financial revenues, including from climate finance and biodiversity offsets.

Who is Angola's New Energy & Environment Officer?

Gassien is part of it. An energy and environment officer with UNHCR, she's charged with working alongside the Angolan Ministry of the Environment to ensure that the land, soil, and water of this corner of the country have a durable solution as well.

What is the environmental framework law in Angola?

This is facilitated by the Environmental Framework Law (Law No. 5/98 of 19th June), adopted by the Government of Angola (GoA) to account for the need to prevent and mitigate against potential adverse social and environmental

impacts of projects.

What are the basic principles of Angola's environmental law?

This Law, consisting of 37 articles divided into seven Chapters and one Annex, establishes basic principles to be carried out by the Government of Angola on the following issues: 1) natural heritage protection; 2) ecosystem preservation and 3) environmental conservation, in order to guarantee the quality of human life.
