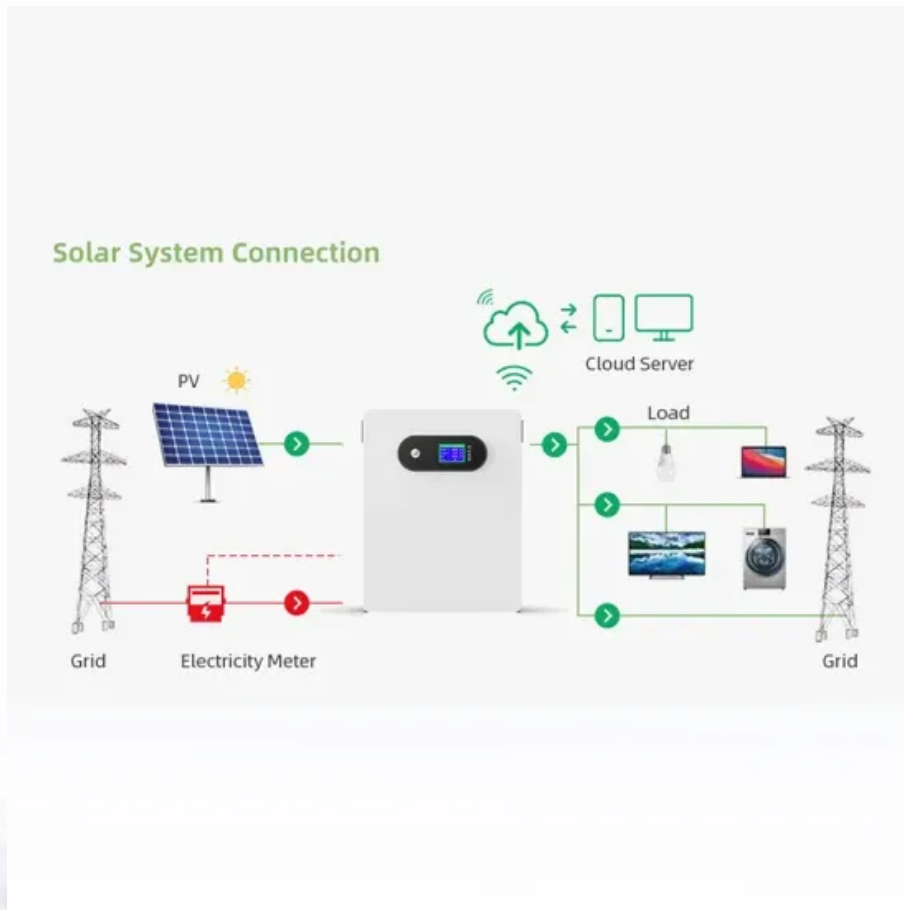

Every six months, ERSE publishes information (PT) comparing energy prices in Portugal with other European Union countries' prices. Annually, ERSE approves tariffs and prices for electricity, valid for a calendar year (January to December). Exceptionally ERSE can approve tariffs and regulated prices for a different timeline.

Is electricity available in Portugal?

Electricity in Portugal is widely available and increasingly green. Redes Energeticas Nacionais (REN) oversees power transmission and supplies the national grid with electricity. There are two kinds of electricity supply in Portugal, each with its own average price: the regulated market and the

liberalized market.

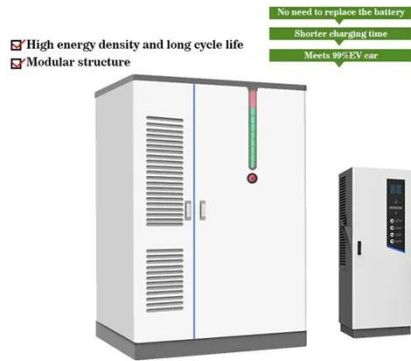

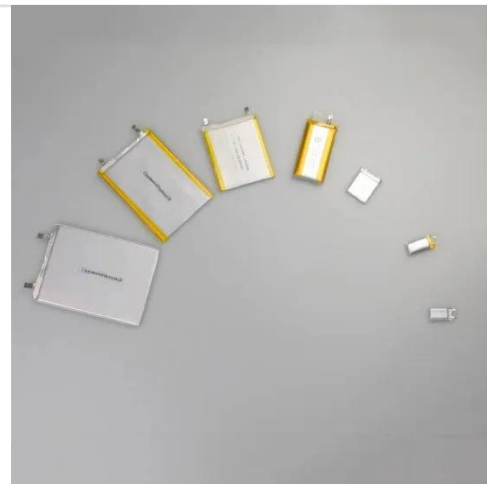
