# Pretoria solar photovoltaic panel export tariff



## Overview

---

The Commission recommended that the rate of customs duty on PV modules/solar panels, classifiable under tariff subheading 8541.40.10 (new 8541.43), be increased from free of duty to 10% ad valorem, by way of creating an 8-digit tariff subheading. What is a photovoltaic tariff?

The tariff subheading reads, " Photovoltaic cells assembled in modules or made up into panels." The rate of customs duty is 10% (General), 0%/free (European Union/United Kingdom), 0%/free (European Free Trade Agreement), 0%/free (Southern African Development Community); 10% (MERCOSUR), and 0%/free (AfCTA).

What will the DTIC do with the existing solar panel tariff?

As part of the new draft measures, the DTIC is reviewing the existing solar panel tariff alongside proposals to introduce wider tariff increases across the renewable energy value chain.

What is ITAC doing about solar tariffs?

In addition to tariff increases, ITAC is considering adjustments to rebates, particularly the existing rebate on imported solar panels. The commission is also exploring the possibility of introducing new local-content provisions to incentivize the use of domestically produced components in renewable energy installations.

Which solar panels are not subject to new import duties?

In light of these developments, securing stock that has already cleared customs before the duty's implementation is crucial. IBC SOLAR South Africa has recently received new stock of LONGi Hi-MO X6 Max (LR7-72HTH 615M) solar panels, which are not subject to the new import duties.

Will solar panels raise customs duties?

The measures, published for public comment by the International Trade

What is the purpose of a solar tariff?
