What is the highest export tariff for solar panels?

The highest export tariff currently on offer is the Solar Savings Exclusive tariff from Good Energy, which pays 40p/kWh; however, it's only available to customers who have bought both solar panels and a battery from Good Energy Solar or JPS Renewables. How is the solar PV industry adapting to changing trade policies?

The solar PV industry demonstrates remarkable resilience in adapting to evolving trade policies through strategic diversification and innovation. Companies are increasingly establishing regional manufacturing hubs to mitigate tariff impacts and reduce supply chain vulnerabilities.

Why did the US impose a tariff on solar panels?

The U.S. government finalised steep levies on imports of solar cells and modules from Vietnam, Malaysia, Thailand and Cambodia in April, following two rounds of tariffs in June and November last year, to prevent dumping by mostly Chinese-owned factories in these countries.

Does the Vatican have solar power?

While not yet fully powered by renewables, the Vatican has steadily expanded its solar infrastructure since 2008: over 2,394 photovoltaic panels—many atop the Paul VI Audience Hall—already generate around 300 MWh of electricity annually.



How does the Vatican regulate imports & exports?

Vatican City, while small in size, maintains a structured framework to oversee its trade operations. Two prominent regulatory authorities play essential roles in ensuring compliance with import and export regulations: the Pontifical Council for Justice and Peace and the Customs Agency.
